DEED OF VARIATION TO THE FUNDING AGREEMENT

THIS DEED is made the 9th day of April 2025

BETWEEN

- 1) The Secretary of State for Education (the "**Secretary of State**"); and
- 2) **Delta Academies Trust** with registered number 07386086 whose registered address is at Education House, Spawd Bone Lane, Knottingley, WF11 0EP (the "**Company**")

Together referred to as the "**Parties**".

INTRODUCTION

- A. The Parties entered into a Funding Agreement dated on or around 1st April 2011, as novated and varied by a Deed of Novation and Variation on 28th August 2019 and by a further Deed of Novation and Variation on 20th November 2023 (the "**Lincoln Castle Supplemental Funding Agreement**"), relating to the establishment, maintenance and funding of an Academy in accordance with the Supplemental Funding Agreement.
- B. The Parties now wish to vary and amend certain terms and conditions of the Lincoln Castle Supplemental Funding Agreement in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Lincoln Castle Supplemental Funding Agreement.

1. INTERPRETATION

- 1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Lincoln Castle Supplemental Funding Agreement.

2. VARIATION OF THE FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from the date of this Deed the Lincoln Castle Supplemental Funding Agreement shall be amended as follows:
 - 1) At the 'Age range' in the Summary Sheet the figure '11-18' shall be removed and re-instated with '11-16'.
 - 2) At the 'Number of sixth form places' in the Summary Sheet the figure '155' shall be removed and re-instated with 'N/A'.
 - 3) At clause 2.B the first line shall be removed and reinstated with '*The planned capacity of the Academy is 1041 and the age range is 11-16*'.
- 2.2 Except as varied by this Deed, the Lincoln Castle Supplemental Funding Agreement shall remain in full force and effect.

3. GOVERNING LAW AND JURISDICTION

3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.

3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

4. COUNTERPARTS

4.1 This Deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.
